Game Times:

Mites will play three 10-minute 30-second periods with changes every 1:30

Squirts will play three 12-minute periods

Peewee and up will play three 15-minute periods

All games will be preceded by a three-minute warm-up, starting when the Zamboni doors close.

Team Rules:

No team may roster anyone who is a senior in high school

No player may be on a roster for more than one team in the same division

Suspensions lasting longer than this season will be strictly enforced onto the individual player's High-School or Travel team

Penalties:

Mite: 1 minute minor, 2 minute double minor, 3 minute major + game misconduct

Squirt: 1:30 minor, 3 minute double minor, 4 minute major + game misconduct

Peewee and up: 2 minute minor, 4 minute double minor, 5 minute major + game misconduct

Checking for Bantam and HS levels

Head Check: *A minor, double-minor, or major penalty will be assessed to any player who recklessly or intentionally contacts a player in the head, including with the stick or by an illegal body check.*

2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown of my participation in Floyd Hall Arena programs, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and
3. I willingly agree to comply with the stated and customary terms and conditions for participation in these programs. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,

The arbitration shall be pursuant to the rules of the American Arbitration Association. The arbitrators shall apply the Federal Rules of Evidence to all proceedings.

Arbitration shall be commenced within one (1) year from the date on which any alleged claim first arose. Further, the arbitration shall be held in the town where Floyd Hall Arena is located, unless otherwise mutually agreed to by all parties. The submission to the American Arbitration Association shall be unlimited and the arbitration award may be enforced by any court of competent jurisdiction.
